### Human Life PAC Rules (Since 1980)

- All candidates must submit a completed questionnaire (each election cycle) to receive an official assessment or endorsement.
- **\*When an incumbent faces a pro-life challenger, previously endorsed pro-life incumbents take precedence over new candidates;**
- **\*The new candidate is listed as in "100% Agreement" status with Human Life PAC.**

**3+ Missed: *Partial Agreement***
